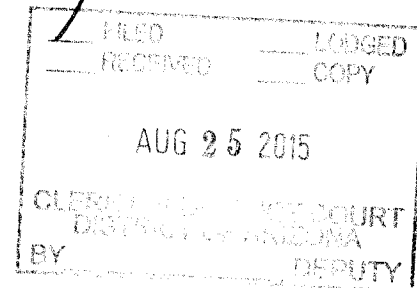

LIFT SEAL OF FILE**


Plaintiff Federal Trade Commission respectfully files this Notice to Lift Seal of File in the above-captioned case. On August 21, 2014, the Court issued an Order Extending the Temporary Seal of File. Dkt #26, Seal Order. According to the Seal Order, the seal lifts upon the earlier of "4:00pm MST, Friday, August 28, 2015, or when counsel for the FTC informs the clerk of the court that the seal is no longer necessary, whichever occurs first." Dkt #26, Seal Order, p. 2.

On August 25, 2015, Plaintiff notified asset holders of the asset freeze, and the Receiver took over operations of the business, all pursuant to the TRO. Therefore, the seal of the file is no longer necessary.


